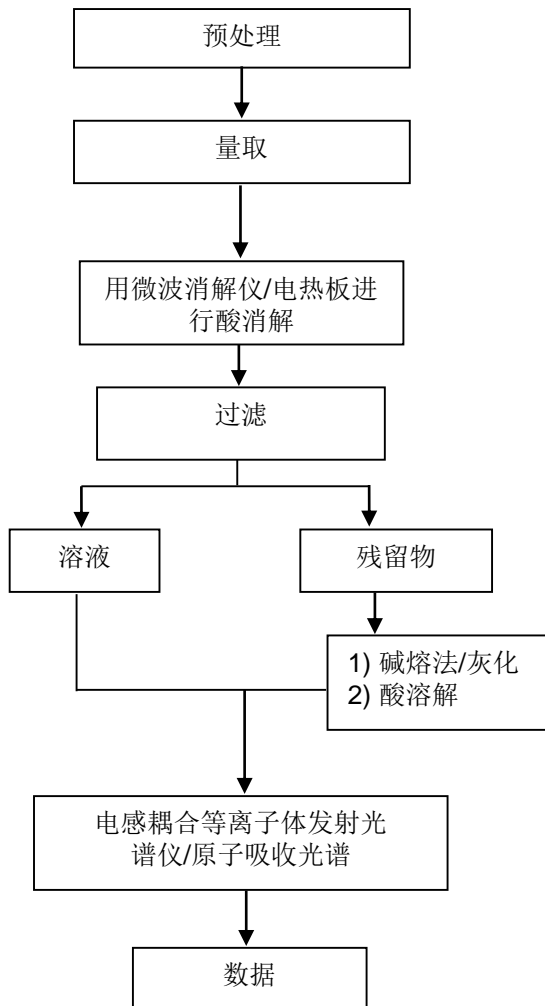

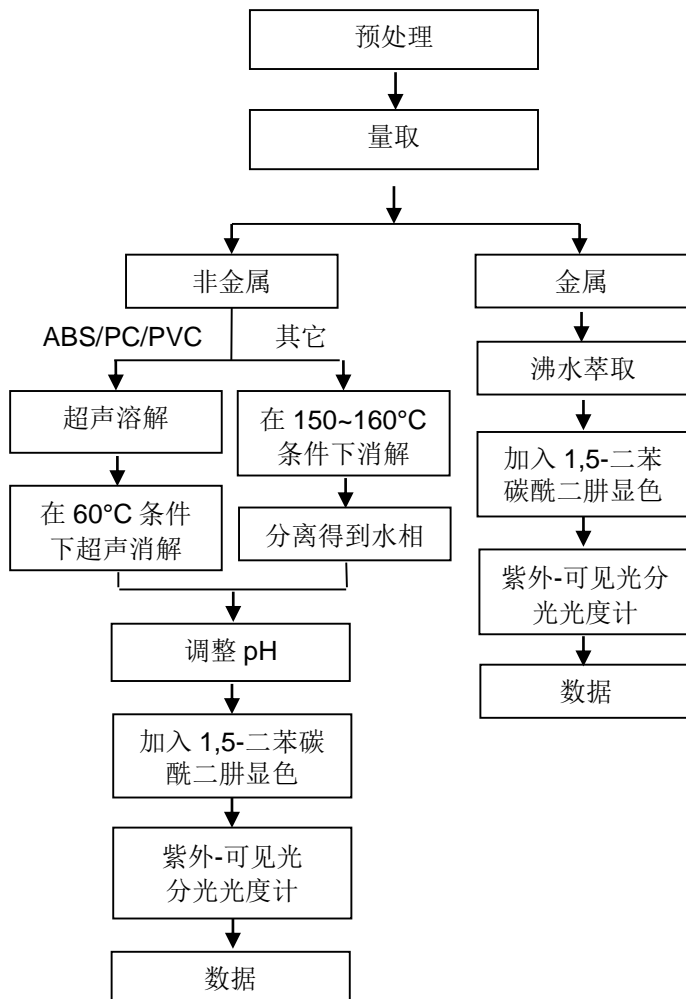

六价铬检测流程图

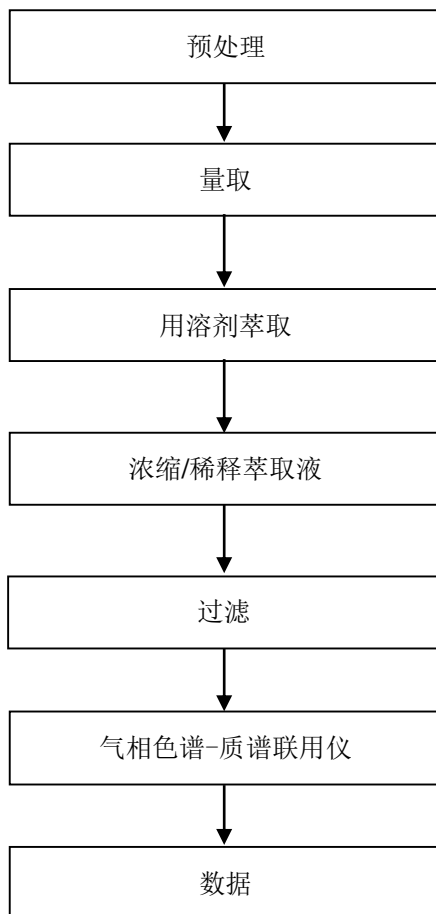

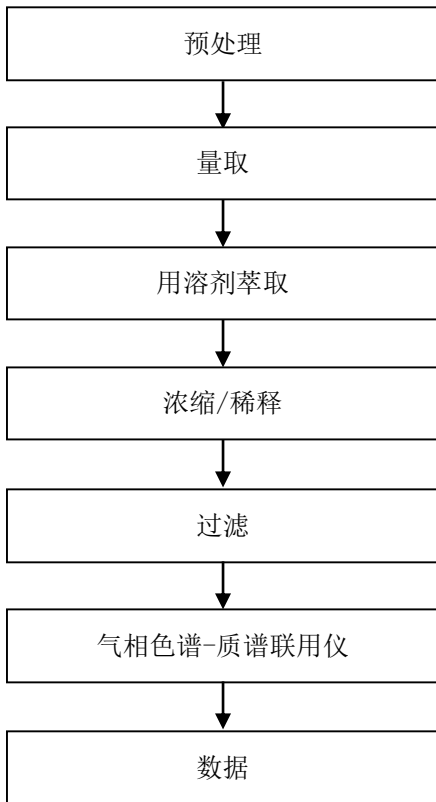

Phthalates 检测流程图



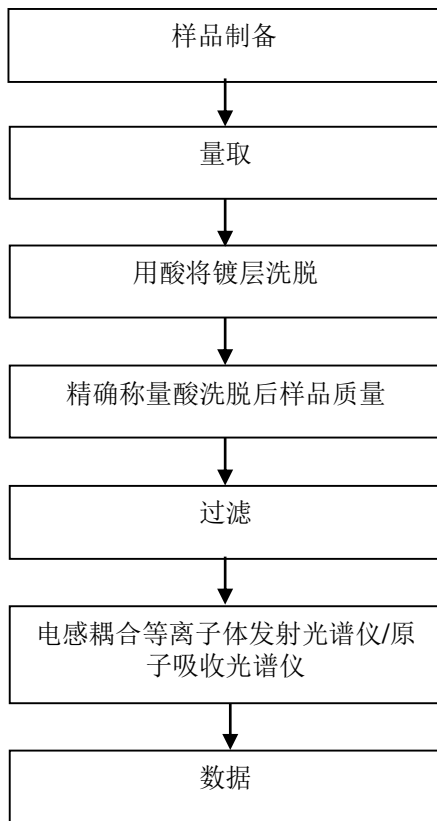

镀层元素检测流程图



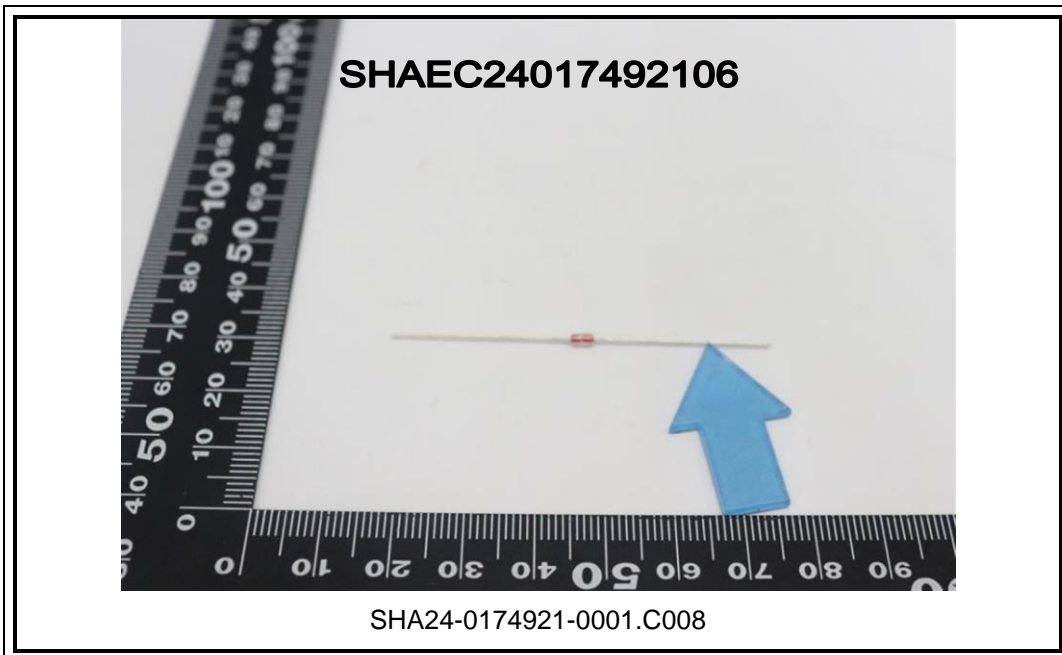
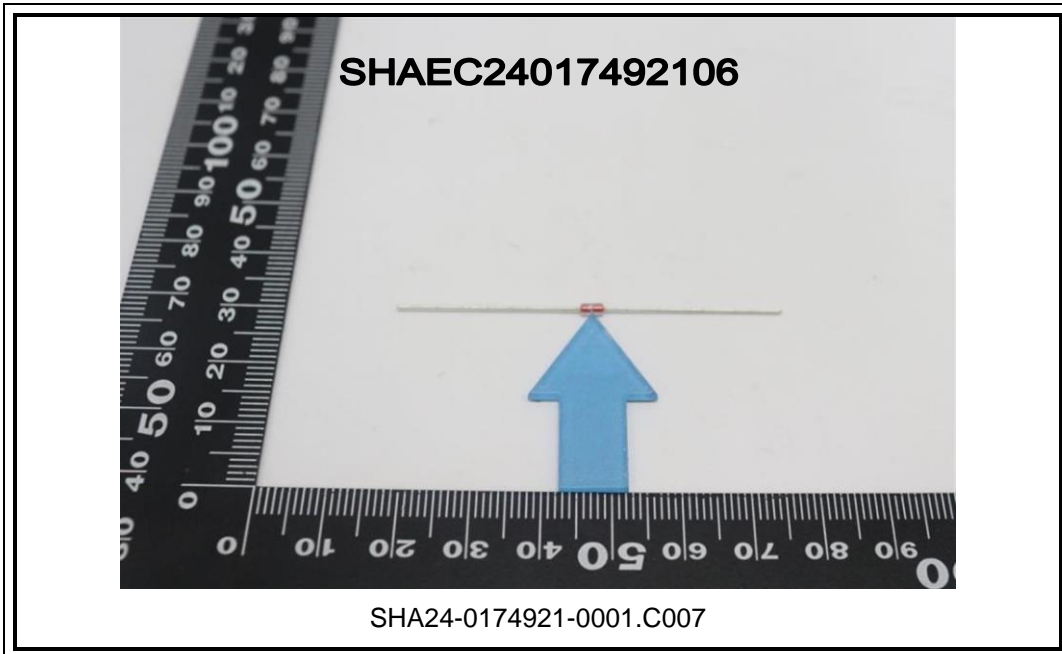

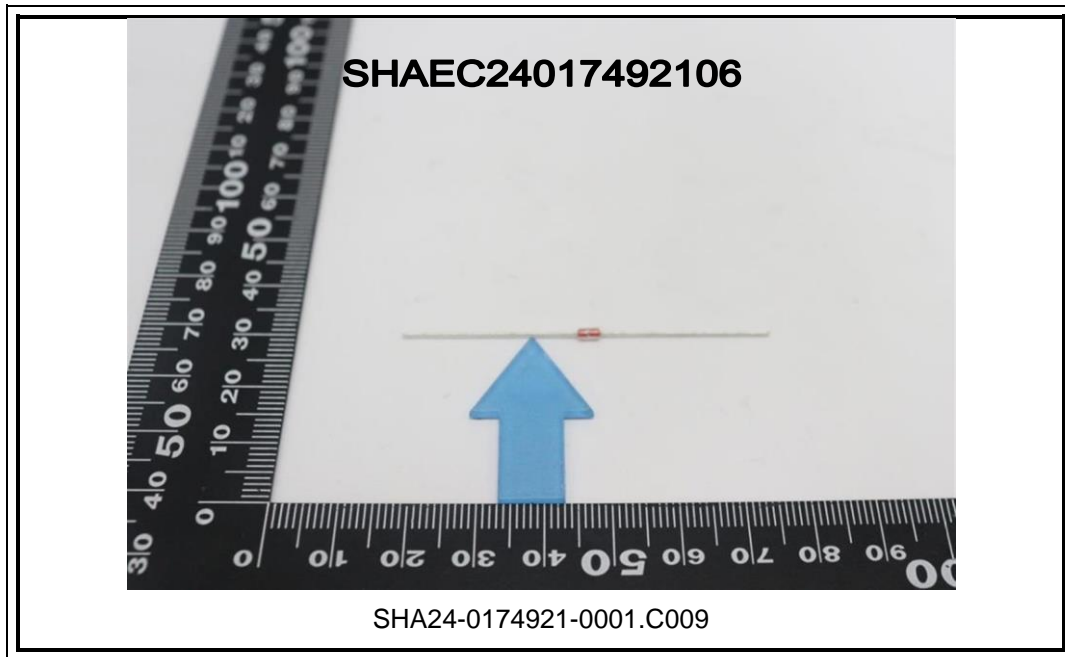
